




# What is environmental response?











## Environmental response criteria

- Environmental Response can be many things
- Fuel spills, facility fires, Sanitary Sewer overflows, train derailments, transportation related incidents, etc.
- "Emergency" means something different to everyone

# What does SCDES consider an "emergency" for an environmental response?

Any material released, accidentally or intentionally, that creates a hazard to the environment and/or poses an immediate public health risk.

The release may be ongoing or has been stopped.

## **Authority**

- SC Pollution Control Act
- SC Oil and Gas Act
- Hazardous Waste Management Act
- Safe Drinking Water Act
- Solid Waste Management Act
- SCDES is the lead state agency for directing the assessment of the radiological impact of a Nuclear Power Plant incident

## Division of Environmental Emergency Response

- Monitor 24-hour Emergency Contact telephone line for the reporting of environmental emergencies
  - Oil and hazardous material releases (fixed facilities and transportation)
  - Fish kills
  - Radiological material releases (fixed facilities and transportation) Monitor and advise on release containment and cleanup

## Response organization


- Central Office: DEER Central Office Duty Officer (CODO)
  - Receive the original notification
  - Dispatch region responder
  - Provide chemical /responder safety information as needed
- Region Offices: Regional On Scene Coordinator (ROSC)
  - Regional offices with response personnel stationed in 13 subareas.
  - Provide primary response personnel and coordination with the responsible party

#### Departments initial contact

24-hour Emergency Contact Line: 888 481-0125

- Telephone is answered by SCDES on-call staff during normal work hours (8:30 a.m. to 5:00 p.m.)
- Telephone is answered by SC Emergency Management
  Division's Warning Point after hours, weekends, and holidays. DEER
  on-call staff member is contacted and will return the call to gather
  specifics and appropriate logistical concerns.
- CODO does receive NRC reports

#### Tier II / RMP Facilities Overview

The Emergency Planning & Community Right-to-Know Act (EPCRA) requires facilities storing any substance for which a safety data sheet (SDS) is required by OSHA and in quantities exceeding the Threshold Planning Quantity (specified for Extremely Hazardous Substance or 10,000 pounds for all other substances) to report these substances to the state, Local Emergency Planning Committees (LEPC's) and fire departments on a Tier II form.

The SC State Emergency Response Commission (SERC) requires an annual submission of Tier II reports by March 1 from qualifying facilities.


DES requires the use of E-Plan to satisfy the SERC'S Tier II reporting requirements. E-Plan is a web-based information system that holds facility-specific hazard information. Facilities sign up for an account in E-Plan and authorize a user to have access to the system.

#### Risk Management Program (RMP) Rule

Section 112(r) of the Clean Air Act Amendments requires Chemical Accident prevention processes to be implemented at facilities that use certain hazardous substances. Facilities holding more than a threshold quantity of a 112 (r) regulated substance in a process are required to implement a Risk Management Program. The regulations require owners or operators of covered facilities to submit an RMP to EPA. Those federal regulations have been delegated to SC DES (BAQ-Air Toxics Section) to inspect and enforce.



# An osprey and two green herons that were rescued from the pond








# Initial Response Actions


- Determine jurisdiction
- Contact the Municipal Separate Storm Sewer System (MS4)
- Visit the site
- Determine the source of the pollution


#### **Initial site visit**













## Objectives

- Speak with the potential responsible party
- Stop the discharge into the pond
- Communicate with other agencies/partners
- Evaluate the impact to the receiving waters
- Have the storm drain system cleaned
- Oversee pond remediation






# Other Partners Involved

#### Final outcome

- The City issued a Notice of Violation to the responsible party because it was their first offense, and they took responsibility for the clean up.
- Clean-up costs were estimated to be \$20,000-\$30,000.
- The public reacted with outcries for the business to be boycotted so they also lost revenue.
- Some birds died as a result of this incident, and some were able to be released.

- Not compliance inspections
- Coordination with facilities
- Scheduled visits
- Joint exercise




#### Coordination

- Scheduling via phone and email
- We do not want to interrupt facility processes
- Would love to attend joint visits and exercises



#### **Expectations**

- Site map
- Facility emergency contacts
- Hours of operation and security
- Stormwater discharge and containment
- Typically, 2-6 SCDES employees and could be 1-4 hours depending on the activity




### **Expectations**

- We want to serve the regulated community
- Is there a Tier II or SPCC (Spill Prevention Control and Countermeasure)?
- Not an inspection want to be proactive
