Fact Sheet and Announcement of Administrative Record

DHEC's Removal Activities

The South Carolina Department of Health and Environmental Control (the "Department" or "DHEC") is responding to the release of hazardous substances at the Horton Sales Development Corporation Site (the "Site") located at 1870 Piedmont Highway in Piedmont, South Carolina.

The Department collected several surface water and sediment samples from Mill Creek and soil samples in the area surrounding the Site's washhouse and sump area. The sampling results indicate that hazardous substances have been released at the Site. There are an estimated 12,000 large containers stacked haphazardly at the Site. These large containers are called intermediate bulk containers (IBCs) or totes, and can hold up to a volume of 275 to 330 gallons. The Department and its contractor are presently cleaning up the Site by sampling containers, consolidating waste materials, and properly disposing of these materials at offsite permitted facilities.

The cleanup crew must wear protective clothing when sampling and working with each container. The Department expects these removal activities to take approximately 9 to 12 months. As part of the removal activities, the Department is taking measures to prevent or minimize any offsite contamination. Once the removal activities are completed, the surface and subsurface soil and the area's groundwater may be sampled.

Community Involvement

DHEC is committed to early, direct, and meaningful public involvement in the State's Superfund process.

The Site Assessment and Remediation Division is developing a CERCLA Community Involvement Plan (CIP) and a mailing list for distribution of information to interested parties. The Department is seeking input in the development of the CIP and the mailing list. Please submit your community concerns and comments to:



Horton Sales Operations

- Horton Sales operated as a container recycling business that received large intermediate bulk containers ("IBCs") from industrial and commercial businesses.
- Although businesses were to ship empty IBCs to the Site, it appears that Horton Sales accepted shipments of IBCs that contained a wide variety of hazardous and non-hazardous substances.
- Horton Sales IBC recycling process:
 - If IBCs contained liquid product, employees would drain remaining liquid product and then rinse out the IBCs in the washhouse;
 - If IBCs contained a sludge-like product, an oil/water separator was used to separate liquid from the solids; then employees would rinse out these IBCs in the washhouse; and
 - The rinse water from washing out the IBCs flowed into floor drains in the wash house and then to one of three in-ground concrete tanks/sumps.
- At multiple times, these sumps overflowed and the wastewater was released into the Gantt Sewer District sanitary sewer system or to Mill Creek.
- The rinsed IBCs that were in good condition would be resold to businesses.
