Purpose:

Any activity, such as dredging, filling, construction or alteration in, on, or over a navigable water, or in, or on the bed under navigable waters, on in, or on lands or waters subject to a public navigational servitude including submerged lands under the navigable waters of the state must apply for a permit issued by the Department of Health and Environmental Control (DHEC). No Construction in Navigable Waters Permits are required for activities in the critical area that are under the exclusive permitting authority of DHEC's Office of Ocean and Coastal Resources Management.

ITEM-BY-ITEM INSTRUCTIONS FOR COMPLETEING THIS FORM

Section 1: (Applicant/Agent Information)

Enter the legal name of the applicant(s) or company applying for the permit. Enter applicant/company complete physical address and mailing address (if different from physical address), and telephone number.
